Subject: Filming permit- Snæfellsjökull National park

The Environment Agency of Iceland has received an application from ÜberRot GmbH Dated April 9th, for filming permit within Snæfellsjökull National park.

Snæfellsjökull is protected as a national park cf. Regulation no. 568/2001. All commercial filming projects within the national park are subject to a permit from the Environment Agency of Iceland according to art. 17 in the Regulation.

Description of the project:

Filming will take place at Norðurþúfa in Snæfellsjökull and in the lava field close to Dritvík. Drone will be used to film hiking actors and extras. Drone shots will be taken in altitude less than 100 meters and above 20 meters to film actors within the landscape. Hiking equipment, clothes, sticks and shoes, will be used as props. There is no need to go of hiking paths and roads. The film crew is 6 people. Filming will take place for 2 hours on May 20th and for 4 hours on May 22nd 2019.

Impact assessment:

The Environment Agency of Iceland considers the project not likely to have negative affect on the area if conditions for the permit are followed. Due to number of visitors visiting the sites applied for, flying a drone can have negative impact on the visitor 's experience. Flight time should therefore be kept as short as possible.

Conclusions and conditions:

The Environment Agency of Iceland hereby grants ÜberRot GmbH a permission on its behalf to film within Snæfellsjökull national park on May 22nd 2019, as described above, on following conditions:

- Keep this letter with you on site during the project. The permit conditions should be introduced to the staff before the work begins.
- If the dates of the project or project description changes the Environment Agency shall be notified as soon as possible.
- The applicant shall contact rangers in the areas 24 hours before the film crew arrives in the area and inform him on your intentions.
- Crew members should always stay on authorized paths/tracks/roads.
- Fauna, geological formations and landscape should not be disturbed in any way.



- All disturbance to animals and wildlife is strictly prohibited.
- The crew should be conscious of other guests on the sites and make sure that filming causes as little disturbance as possible to other visitors. During early morning and late afternoon, there are less people visiting the sites.
- The permit conditions should be introduced to the staff before the work begins.
- All traces of the work must be removed carefully off the site by the end of the work/project.
- Take off and landing of the drone should be in areas where number of people is minimum. It is not allowed to enter areas that are closed for traffic.
- An unmanned aircraft should never be flown near people. Please take precaution not to disturb people's experience, their safety or personal privacy, nor the general peace of the protected areas filmed.
- The conductor of the unmanned aircraft is responsible for the aircraft within the protected area. This includes responsibility so that people, fauna and nature is unharmed because of the aircraft's use and that no permanent mark be left on the site in question. Should the aircraft crash, all components from it must be collected and removed from the area.

If the developer causes damage to the nature, according to art. 87 in the Nature Conservation Act no. 60/2013, the Environment Agency of Iceland can, according to the Nature Conservation Act, f.e. ordered the licensee to fix damage to the nature and vegetation and/or stop the project.

The usage of a drone shall be according to regulation no. 990/2017 on the operation of remotely piloted aircraft (https://www.icetra.is/aviation/drones/). Please note that according to the regulation all drones used for comercial flight need to be registered at the Icelandic Transport Authority.

Permission fee:

Environment Agency of Iceland charges a fee for processing applications for permits in protected areas based on Article 92 of Act no. 61/2013 on Nature Conservation. The fee for cinematography and/or photography is 52.600 ISK according to art. 24. b. in the agency's tariff no. 535/2015.

Supervision:

The Environment Agency will supervise the project. The supervisor will be a ranger from the Environment Agency.
